



## Asia Pacific Regional Situation Report

July 16, 2020

### Situation Overview

**COVID-19 Cases: 1,267,580**  
**COVID-19 Deaths: 34,640**

Countries across the Asia Pacific are beginning to ease lockdowns due to an overall slowing trend of COVID-19 cases. Phased reopening is being rolled out in many areas as countries return to some sense of normalcy. However, this is not the case for all countries. The region continues to see a spike in confirmed COVID-19 cases in countries like India (849,553) and Indonesia (74,018) according to the [WHO](#). World Vision remains vigilant and is monitoring the situation to respond to the continuing spread.

World Vision across the Asia Pacific has started to conduct lessons learned workshops to identify the key learnings, best practices and challenges from its COVID-19 emergency response and is documenting these learnings to inform future responses. For example, in Bangladesh, the collaboration between humanitarian and development programming, at levels and functions within the organisation (whole office approach) and other key external stakeholders was widely celebrated. The Bangladesh field office was able to identify best practices and learning which will inform their next early recovery phase of programme designing and operation.

### Key Messages



Asia is facing twin health and economic crises. Healthcare access is a significant challenge, both due to virus dynamics and the subsequent pressure on the healthcare system. Financial resources to pay for food, transportation and healthcare are difficult to obtain with widespread job losses. Boys and girls equally suffer from anxiety, loneliness and boredom and may experience more violence and abuse at home. Their parents and caregivers have given clear signals that dealing with changing behaviours of their children is difficult. And now with lockdowns easing, more challenges abound for Asia's children.



Measures taken by governments and partners during the crisis need to lay the foundation for long-term improvements in the social safety net and essential public services. Given the stakes, such desperate times call for bold solutions. We can do no less for Asia's children.
