



ANNUAL PROGRESS REPORT

October 2021 - September 2022 | Honduras

SUMMARY

In fiscal year 2022, World Vision began our six-year Finish the Job campaign in Honduras, aiming to reach 650,000 vulnerable Hondurans in 49 municipalities with clean water by FY27. Despite challenges such as delays in construction materials and temporary school closures that prevented the full achievement of our FY22 targets, we successfully reached over 34,000 Honduran children and adults with access to clean water. And we are poised to achieve much more.

During this reporting period, the Honduras Water, Sanitation, and Hygiene (WASH) team focused on delivering quality, sustainable WASH interventions in several key areas.

Water supply: In partnership with communities, municipal authorities, and nongovernmental organizations, World Vision completed a network of 43 water systems, fixing an old network that released contaminated

water and caused the spread of waterborne diseases. We also installed 18 new water taps and rehabilitated 60 more, making clean water accessible to 8,726 families in 59 communities—as well as 50 schools and 23 healthcare facilities.

Sanitation and hygiene: More than 2,100 families learned safe sanitation and hygiene practices, along with how to build their own latrines and handwashing stations. Additionally, 63 new WASH committees—192% of target—received training on latrine location and other sanitation priorities. By enacting the lessons they learned, 18 communities were certified as free of open defecation in FY22.

World Vision also equipped 33 schools and 22 health centers with sanitation and handwashing facilities. These facilities help reduce contamination of soil and groundwater sources, and prevent deadly diseases such as cholera.

Governance and finance: Across multiple municipalities, World Vision trained key stakeholders—including community water boards and members of the Ministry of Health—on the WASH Sector Framework Law and water management regulations, helping them understand their rights and methods for holding local government accountable for delivering quality WASH services.

Water security and resilience: In partnership with the Forest Conservation Institute, World Vision trained community water boards on the protection and management of micro-watersheds and supported community-led micro-watershed projects. These efforts were similar to our prior year's work with coffee farmer Genrri (seen at right) from San Marcos.



PROGRESS TOWARD FINISHING THE JOB



Coffee farmer Genrri (above) is committed to ecosystem restoration in his village of San Marcos. "We made the decision to buy a piece of land in order to reforest it [and] reduce water pollution," said Genrri, a participant in World Vision's WASH and Transforming Household Resilience in Vulnerable Environments programs. "Now ... we have a total of 11.3 acres of protected, lush forest." After training community members on environment protection, Genrri said, the change to his community "is something extraordinary, something that is priceless." Read Genrri's full story.

PLANS FOR THE NEXT SIX MONTHS

After recently hiring a new WASH Director, Tupac Mejia, to replace the late Javier Mayorga, we have now built the team needed to finish the job in Honduras. Given the delays in construction materials during FY22, World Vision made a significant purchase of PVC pipes, fittings, and steel rods, which have been placed in safe storage for upcoming water projects. In the first half of FY23, we plan to purchase additional construction materials for building sanitation facilities in schools, health centers, and households. We will also begin implementing six municipal water and sanitation plans in San Matías, Jacaleapa, El Paraíso, San Isidro, Jesús de Otoro, and San Juan.




Water Honduras Report FY22 Annua
