# **ANNUAL PROGRESS REPORT**

October 2019 – September 2020 | India

#### **SUMMARY**

Despite the impacts of COVID-19 and Cyclone Amphan, the India Child Protection project continued to empower, teach, and advocate for children and their families as well as provide resources for basic needs.

Despite this progress, violence against girls continued to be a significant threat during the pandemic. To address this, nine Girl Power groups from Darjeeling District, in partnership with Border Security Force and District Legal Services Authority, launched an advocacy campaign and used street theater to create awareness against human trafficking.

The project team distributed dry rations and personal hygiene kits to women and children living in the red-light district and vulnerable families with girls who are at risk of trafficking. Child-Friendly Learning and Recreation Centers (CFLRCs) closed due to COVID-19 restrictions. To continue teaching and learning, the team started online math and English classes for older students and created worksheets for younger students to pick up and return when completed.

Since in-person meetings were restricted, online counseling was offered to Girl Power group members, children in CFLRCs, and survivors in aftercare homes. Discussion topics included COVID-19 awareness, mental health during lockdown, and recognizing and reporting child sexual abuse.

Cyclone Amphan was the most violent cyclone to hit India in over 100 years, destroying homes and livelihoods. Emergency assistance was provided to 4,200 families in South 24 Parganas District and Kolkata redlight districts.

#### **PROGRESS ON CORE ACTIVITIES**

**39,936** children educated on how to prevent trafficking and promote safe migration

1,824 girls participated in Girl Power groups



## **KEY LEARNINGS**

Because of World Vision's active community presence, the project team was able to establish a relationship and build trust with the local police. This has helped improve police response and involvement when incidences are reported. We also have built trust with communities in the red-light district by creating and enrolling children in CFLRCs.

More than half of the Girl Power groups formed have taken at least one action to protect girls in their communities, including stopping child marriages, reporting child abuse incidents to police, or reporting missing children incidents to police.

#### LIFE-OF-PROGRAM UPDATE



Goal\*

**532,418 people**, including 188,967 children, reached to prevent children from being trafficked for sex and protect them from all other forms of violence.

Actual 258,025 people, including 155,317 children, have benefited from ministry activities since October 2017.

## PLANS FOR THE NEXT SIX MONTHS

Over the next six months, the India Child Protection project plans to:

- Lead a legal awareness program for Men Care groups
- Develop a training for boys to reduce sexual gender-based violence •
- Train village-level child protection committees on how to respond to different child protection incidences, including trafficking
- Equip child survivors with job skills to protect them from second generation prostitution
- · Provide counseling for girls living in red-light areas
